



## Nursery Charging Booklet – 2020/21

All payments (except Nursery fees) will be expected to be paid **IN ADVANCE** on a half-termly basis.

This booklet contains a detailed breakdown for each area.

Any payments made cannot be refunded. All payments will be allocated to the correct area and used to cover the costs.

The school no longer uses Schoolcomms for online payments. However, we are happy to receive bank transfers to:

This will ensure we can trace your payment quickly and efficiently.

# Nursery Fees

## Opening hours for Nursery are:

- Term time only - 38 weeks
- Session times:

## Eligibility

Pen Mill Infant & Nursery Academy admits children from the term after their 2nd birthday. To be eligible for a 2-Year-old place (15 free hours per week) your child must be in receipt of 2 Year old funding or if a place is available parents may be able to purchase hours as detailed below. Confirmation of funding will be required before a place is allocated.

Children will be eligible for the Early Years Entitlement (15hours a week) the term after their 3rd birthday. For example, if a child is 3 in February he/she can claim funding after the Easter Holiday.

Some working parents may be entitled to 30 hours free funding for children who are 3 from the term after their 3rd birthday. You will need to visit [childcarechoices.gov.uk](http://childcarechoices.gov.uk) to see if you are eligible. See below for more details.

## Early Years Entitlement Funding

We are in receipt of Early Years Entitlement Funding (EYE) for three and four year olds; this will be available from the term after your child's third birthday.

All fees charged relate to those hours or weeks not funded by the EYE Funding.

Should a session last longer than the EYE Funding available, parents/carers will be required to pay for that part of the session that exceeds the EYE Funding.

Your child is entitled to 15 free hours per week for 38 weeks under the Early Years Entitlement Funding once these hours have been used any additional hours will be chargeable.

## 30 Hours Entitlement for Working Parents

From 1st September 2017 parents who earn around £120 per week (equivalent to 16 hours at minimum wage) or more, may be entitled to claim an additional 15 hours of funded child care. Pen Mill Infant & Nursery Academy will be offering a limited number of places for parents wishing to take up these additional funded hours. From this, you may receive your 30 hours code which you must present, along with your National Insurance number, to the school office where you may register your interest to take up



additional hours. The school will 'validate' your code before your 30 hours place is secured. We will inform you when this is done.

It is the parent's responsibility to inform the local authority if you are no longer entitled to 30 hours (i.e. you stop working or reduce your hours). You will then enter a 'Grace period' by the end of which your child will no longer be able to take up more than their 15 hours 'basic entitlement' or you will be required to pay for additional hours.

## **2 Year Old Funding**

- You will need to apply for 2 year funding.
- Confirmation of 2 year old funding will need to be sent to the school before a place can be allocated.
- All fees charged relate to those hours or weeks not funded by 2-year-old Funding.
- Should a session last longer than the funding available, parents/carers will be required to pay for that part of the session that exceeds the Funding.
- Your child is entitled to 15 free hours per week for 38 weeks under the 2 Year Funding.
- Once these hours have been used, any additional hours will be chargeable.

## **Early Years Entitlement (EYE) –**

- Parents are able to use their Early Years Entitlement (EYE) of 15 hours a week for their child at the setting if they are entitled to funding or 30 hours funding for some working families.
- Maximum EYE hours per – 570 hours over the year,
- Additional hours can be requested for a maximum of 15 hours per week. Requests for additional hours may be made by completing the session time's form. Please ask a member of staff or at the school office.

## **How to Pay for Nursery Fees**

If you are paying for nursery fees, the Finance team will invoice the parent on a monthly basis. The nursery team will inform the finance team of how many sessions will need to be charged for. The invoice will detail the charges per week and how to pay via bank transfer, cash or cheque. All other charges will be required to be paid in advance.



## Nursery Lunches

Below is a breakdown of charges if you wish your child to have a hot meal at lunchtimes. Payment is expected **IN ADVANCE** on a half-termly basis.

If your child only has a hot meal on certain days, you will be required to work out how many days and a total cost.

Nursery Lunches daily charge - £2.50 per day or £12.50 per week for every day.

Term 1: 03 September – 22 October 2020 (36 days) - £90.00 for half a term to attend everyday  
Term 2: 02 November – 17 December 2020 (34 days) - £85.00 for half a term to attend everyday  
Term 3: 05 January – 12 February 2021 (29 days) - £72.50.00 for half a term to attend everyday  
Term 4: 22 February – 01 April 2021 (29 days) - £72.50 for half a term to attend everyday  
Term 5: 19 April – 28 May 2021 (29 days) - £72.50 for half a term to attend everyday  
Term 6: 07 June – 21 July 2021 (33 days) - £82.50 for half a term to attend everyday

Please note - All inset days / Bank Holidays have been taken into account.

Half term 1 and 2 = Autumn Term

Half term 3 and 4 = Spring Term

Half term 5 and 6 = Summer Term

## Late Pick-up charge

From September 2020, the school will be charging parents for any late pick-up of their child. As follows:

Late collection after 11.45am (morning session), 3.15 pm (afternoon session) or 12.15pm (lunchtime club) - £2.50

If you collect your child late by 30 minutes or more - £10.

Reason for the late collection will need to be provided to nursery/reception upon receipt of your child. This will then be reported to the Head Teacher prior to invoicing.

**This cost is payable by ALL parents.**
